NOMINATED STUDENT-ATHLETES AND THEIR FAMILIES WERE ALSO INVITED TO ATTEND AND WERE RECOGNIZED FOR THEIR ACCOMPLISHMENTS. \$8,000 IN AWARDS WERE DISTRIBUTED TO COACHES, AND \$4,000 IN STUDENT-SCHOLARSHIPS WERE AWARDED.

IN FALL 2016, THE FOUNDATION ORGANIZED AND FINANCED THE OKCPS ATHLETICS COACHES' SOCIAL AT THE START OF THE SCHOOL YEAR. RESOURCES PARTNERS AND VOLUNTEER ORGANIZATIONS WERE INVITED AND PRESENTED TO EDUCATE COACHES ON PROGRAMS THEY AND THEIR TEAMS COULD ACCESS IN THE 2016-2017 SCHOOL YEAR.

IN FALL 2016, THE FOUNDATION ORGANIZED AND FINANCED THE FIRST EVER OKCPS ATHLETICS CHEER CAMP. ALL OF THE CHEER PROGRAMS FROM THE DISTRICT'S 15 PROGRAMS WERE INVITED TO PARTICIPATE FOR FREE IN THE DAY LONG CAMP.

LASTLY, IN JANUARY 2016, THE FOUNDATION ORGANIZED AND FINANCED THE OKCPS ATHLETICS WINTER COACHING CLINIC THAT FEATURED CLINICIANS ACROSS ALL SPORTS CATEGORIES. THE CLINIC WAS HOSTED AT CAPITOL HILL HIGH SCHOOL AND ONE-ON-ONE INSTRUCTION WAS PROVIDED TO ALL COACHES.
