

OFFICIAL RAFFLE RULES

World Cup Match Tickets – USA vs. Paraguay

Sponsor

This raffle (“Raffle”) is conducted by **Fields & Futures Foundation**, an Oklahoma nonprofit corporation and tax-exempt public charity under Section 501(c)(3) of the Internal Revenue Code (“Sponsor”).

Raffle Period

The Raffle begins on **[April 7, 2026, 9 a.m. CT]** and ends on **[April 30, 2026, 11:59 p.m. CT]** (“Raffle Period”). All entries must be received by the end of the Raffle Period to be eligible.

Sponsor’s clock is the official timekeeping device for the Raffle.

Eligibility

- Open only to individuals who are **21 years of age or older** at the time of entry.
- Entrants must be legal residents of the United States.
- Employees, officers, and directors of Sponsor and their immediate family members are not eligible to enter.
- Void where prohibited by law.

By entering, participants represent that they meet all eligibility requirements and agree to be bound by these Official Rules and all applicable federal, state, and local laws.

This raffle is conducted exclusively for charitable purposes by a qualified 501(c)(3) organization in accordance with 21 O.S. § 1051, and net proceeds will be used to further the organization’s tax-exempt mission.

How to Enter

Participants who choose to make a voluntary donation will receive entries into the drawing as follows:

- \$100 donation → 1 entry
- \$250 donation → 3 entries
- \$500 donation → 7 entries

- \$1,000 donation → 15 entries

Bonus Entries:

As a gesture of appreciation, individuals who contributed \$1,000 or more during the *Brokering Futures* campaign (February 1-28, 2026) will automatically receive 10 additional bonus entries.

No Purchase Necessary:

No donation, payment, or contribution is required to enter or win. A donation will not increase the odds of winning. Individuals may enter for free by following the alternate method of entry described in the rules.

All entries must be received and processed within the Raffle Period to be eligible.

All entries become the property of Sponsor and will not be acknowledged or returned.

Prize

Two (2) tickets to attend the FIFA World Cup first-round match: **USA vs. Paraguay.**

- **Approximate Retail Value (ARV): \$2,500 total.**
- Match date, time, and venue are determined by FIFA and event organizers.
- Tickets are non-transferable, non-exchangeable, and not redeemable for cash.
- No substitution of prize except at Sponsor's sole discretion for a prize of equal or greater value.

The Prize does **not** include travel, lodging, meals, transportation, parking, or any other expenses not expressly stated.

Odds of Winning

Odds of winning depend on the total number of eligible entries received during the Raffle Period.

Winner Selection & Notification

- The winner will be selected in a **random drawing** conducted within five (5) business days after the Raffle Period ends.
- The potential winner will be notified using the contact information provided at entry.
- The potential winner must respond within three (3) business days and may be required to complete an Affidavit of Eligibility, Liability Release, and IRS Form W-9.
- If the potential winner fails to respond, is ineligible, or does not comply with these Official Rules, an alternate winner may be selected.

Sponsor's decisions are final and binding in all matters related to the Raffle.

Taxes

The winner is solely responsible for any federal, state, and local taxes associated with acceptance of the Prize. Sponsor will issue a Form W2-G if required by law based on the Prize's fair market value.

Publicity

Except where prohibited by law, acceptance of the Prize constitutes permission for Sponsor to use the winner's name, city, and state for promotional purposes without additional compensation.

General Conditions

Sponsor reserves the right to cancel, suspend, or modify the Raffle if fraud, technical failures, or any other factor beyond Sponsor's reasonable control impairs the integrity of the Raffle.

By participating, entrants agree to release and hold harmless Sponsor, its officers, directors, employees, and agents from any liability arising from participation in the Raffle or acceptance or use of the Prize.

Governing Law

This Raffle is governed by the laws of the State of Oklahoma. Any disputes shall be resolved exclusively in the state or federal courts located in Oklahoma.
